

Members Update: March - April 2022

INPUD's bi-monthly members updates are intended to keep our members and supporters informed about INPUD's recent activities, as well as updates from national/regional networks and relevant news in drug policy.

The following updates cover March through April 2022.

Global Advocacy and Events

65th Commission on Narcotic Drugs (CND)

This year's CND took place <u>14-18 March</u> both online and in Vienna. Due to restrictions in both travel and the number of civil society organisations permitted to attend in person this year, INPUD only attended CND virtually.

The impact of Russia's invasion in Ukraine was heavily felt at this year's CND, with many Member States condemning Russia's aggression and express solidarity with Ukraine. Russia withdrew many of their planned side events as well as its own resolution after the US, Canada, Australia, UK and EU countries stated Russia's aggression made it impossible for them to act in good faith during negotiations. Additionally, Russia's candidate for representation in the UNODC financing working group (FINGOV) lost overwhelmingly to the Latvian candidate in a vote which would normally be decided by consensus. Throughout the week Russia responded to this condemnation by throwing around accusation of other States "politicising" the CND forum, alleging that there were state-linked underground drug laboratories in Ukraine, and even accused Latvia of glorifying Nazism, all which prompted walkouts from Western countries.

Despite these tensions, two resolutions were adopted by consensus at this year's CND:

- A <u>Mexican-sponsored resolution</u> calling on greater international focus, including from civil society, on the links between trafficking of drugs and firearms
- A <u>US-sponsored resolution</u> on trafficking and chemical precursors which engances implementation of the 1988 UN Convention and promotes international cooperation

Two other resolutions (one on alternative development and drug control, another on drug prevention) were tabled but not adopted.

INPUD's side event, *Ending Inequalities for People who Use Drugs: How the Global HIV Response can Transform Drug Policy (and vice versa)*, occurred the first day of CND.

During the panel we brought together speakers from the community, UN agencies and government to review the critical advocacy work by peers last year around the Global AIDS Strategy and 2021 Political Declaration, and why the key targets in each document are important for governments in consideration of drug policy. Panellists also discussed

specific interventions and policies Member States can take to integrate these targets into national drug policy strategies. The event was co-sponsored by Medecin du Monde, UNAIDS, UNODC HIV/AIDS Section, Netherlands and Australia. Everyone can now watch the side event on our <u>youtube channel by clicking here.</u>

In addition to our side event, INPUD also made a virtual <u>intervention</u> during agenda item 7: inter-agency cooperation and coordination. Our intervention called for coordination between all global stakeholders and the community of people who use drugs to embrace the targets set forth in the Global AIDS Strategy and 2021 Political Declaration.

Joint Statement by INPUD, HRI and NSWP for INB Public Hearing

This joint statement was submitted by INPUD, HRI and NSWP to the public hearings regarding an international instrument on pandemic prevention, preparedness and response (INB) which was held by the WHO on 11-12 April, 2022. Our statement urges this instrument to build upon and enhance human rights protections, including:

- Incorporating international standards on derogations to human rights in public health emergencies, highlighting legality, necessity, proportionality and non-discrimination;
- Explicitly express limitation on the role of law enforcement in pandemic response;
- Explicitly acknowledge need for specific protections for communities who face heightened vulnerability;
- Including meaningful participation of communities in the design implementation and evaluation of the instrument.

government crackdowns on human rights activists and gender power imbalances. Having directly experienced and survived harms that include discrimination, incarceration, police violence and overdose, people who use drugs and their advocacy networks are uniquely positioned and motivated to implement community-response work. These projects have restored dignity and purpose to the lives they have saved.

Video: The Wall of Shame - Why Crack Consumption Rooms are Needed in Paris

An estimated thirteen thousand people use crack cocaine in the wider Paris region. Recently the police, who have been harassing the community over the last three decades, even built a wall to block people who use crack from the rest of society. This wall – an ugly and very physical manifestation of the authorities' attempts to separate these crack users from the rest of society – has been nicknamed the Wall of Shame. <u>This</u> <u>new documentary</u>, co-produced with ASUD and DrugReporter, explores the history of crack in Paris, and amplifies the voices of experts and residents who call for a better solution: safe crack consumption rooms.

Video: The Narcofeminism Storyshare Model

In this <u>powerful new video</u> with Drugreporter and the North Carolina Urban Survivors Union, womxn who use drugs share stories about pregnancy, parenting & drug use. The story share model is an important tool for deconstructing the internalized narratives around the drug war. Traditional story share models often reinforce tropes and stigma we find in existing cultural narrative projects. Reproductive Harm Reduction is an inclusive powerful new paradigm focused on pregnant and parenting people who use drugs, and it was born from the Narcofeminism story share experience.

Global Fund Country Coordinating Mechanism (CCM): Guide for People who Use Drugs

This new <u>Global Fund resource</u> aims to help our community better understand how Country Coordinating Mechanisms (CCMs) work and how we can become meaningfully engaged in CCM processes. CCMs play a crucial role within the Global Fund model. However, too often Global Fund programmes implemented at the national level and overseen by CCMs do not perform as well as expected and do not meet the needs of key populations. The main aim of the CCM Evolution project is to equip and strengthen the way CCMs work and operate – including its grant oversight and engagement functions with communities and key populations – in order to make CCMs fit for purpose, maximise their impact, and change a business-as-usual approach. The CCM Evolution builds on a pilot project which was rolled out in 18 countries in 2018 and presents an opportunity for people who use drugs to effectively influence Global Fund programming by identifying gaps, blockages, and bottlenecks to meaningful community participation often experienced within CCMs. Through this process, we can document and propose solutions to strengthen CCMs work so the voices of people who use drugs are listened to, heard, and respected, and our health and rights needs are met.

Global Fund's Community, Rights and Gender (CRG) Strategic Initiative: Short-Term Technical Assistance

The Global Fund's Community, Rights, and Gender Strategic Initiative (CRG SI) offers short-term peer-to-peer technical assistance to communities and civil society, including key population-led organisations and networks, to ensure that barriers related to community engagement, human rights, and gender equity are addressed. The CRG SI consists of three components:

- 1. Short-term technical assistance;
- 2. Long-term technical capacity strengthening (provided by INPUD among others);
- 3. CRG regional platforms.

<u>This guide</u> focuses specifically on how to access the first component – short-term technical assistance (TA).
